

**Pittstown Zoning Board of Appeals
2024 Schedule of Meetings**

Meetings are normally scheduled to begin at 7:00 PM at the Pittstown Town Hall and will only be held if there is active business before the board.

All applications must be received with application fee paid, with 7 copies of supporting application materials, 13 days prior to the scheduled meeting. Plans must be stapled in sets and supporting materials stapled or bound. If a meeting is already scheduled for the month, the Chairman may waive this deadline on a case by case basis. Note that the Town Hall closes at 12:00 PM on Friday, so materials must be received by 10:30 AM.

The Applicant or the Applicant's representative(s) must be present at each meeting where the application being considered is discussed. Without representation, the matter will be tabled until the following month. If the Applicant fails to be represented at that meeting, the Applicant will have to contact the Zoning Board Chairman to be scheduled on a future agenda. After three months of no activity on the applicant's part, they will be notified that their application will be closed without action if appropriate communication is not received by the filing deadline for the 4th month's meeting.
